

Miami-Dade 2045 Long Range Transportation Plan
STEERING COMMITTEE #4
Meeting Summary
Friday, June 8, 2018

A Miami-Dade 2045 Long Range Transportation Plan Steering Committee Meeting was held June 8, 2018 via WebEx. A list of attendees is attached to this Meeting Summary.

1. Introductions:

Carlos Roa, TPO LRTP Project Manager, opened the meeting and welcomed everyone to the meeting. Members present were identified by agency.

2. Florida Turnpike Enterprise Master Plan

Andrew Velasquez, Program Manager Planning and Traffic Engineering, FTE – Traffic & Revenue Consultants presented the Florida's Turnpike Enterprise Master Plan. The presentation included: an overview of Florida's Turnpike Enterprise; Current Initiatives: Centralized Customer Service System (CCSS), SunTrax, and Truck Platooning, and Master Plan Projects including: Ongoing Projects, Funded Projects (FY 2018 – FY 2027), and Unfunded projects.

3. Southeast Florida Regional Household Travel Survey Results

Wilson Fernandez, Miami-Dade TPO, presented the results of the 2016 – 2017 Southeast Florida Regional Household Travel Survey. These results will be incorporated into the SERPM.

4. Southeast Regional Planning Model (SERPM) Version 8 Status Update

Wilson Fernandez, Miami-Dade TPO, also provided a status update on the SERPM. Model validation (SERPM 8) is expected to be complete by Fall 2018. Training will follow.

5. 2045 LRTP Socioeconomic Datasets

Jeremy Goldstein/Wilson Fernandez presented the Miami-Dade County 2045 Data Forecast. The forecast methodology was described. A Cohort-component method was used for population control total and modified shift-share for employment control total, supplemented by review of relevant regional and national trends were used. The methodology documentation is available.

The population and employment summaries were presented. Population is expected to grow from 2,648,000 in 2015 to 3,533,000 in 2045 representing a 33% growth (increase of 885,000) and employment is expected to grow from 1,351,000 in 2015 to 1,814,000 in 2045 representing a 34% growth (increase of 463,000). Various other population and employment summaries were discussed.

The conclusions were:

- Miami-Dade County is primed for continued growth
- Its proportion of the region's population and jobs is forecast to increase
- Growth is found in both urban and suburban areas
- Miami-Dade's demographics are likely to see small shifts in age, income, ethnicity, HH size, etc.

6. Next Steps:

Information about the next scheduled meeting will be provide. The next meeting is scheduled for June 22, 2018.
